# Recharacterization Request

Use this form to request a recharacterization of all or any portion of the contributions made to a Premiere Select IRA or qualified rollover contribution to a Roth IRA or IRA Beneficiary Distribution Account (IRA-BDA). Do NOT use this form for conversions or reconversions. Type on screen or print out and fill in using CAPITAL letters and black ink.

Recharacterizations generally must be completed by the federal income tax filing deadline (including extensions) for the year for which the contribution was made to the first IRA. Recharacterizations may be subject to IRS limits. Employer contributions to a SEP-IRA or a SIMPLE IRA generally cannot be recharacterized as contributions to another IRA. A recharacterization is not considered a rollover for purposes of the one-rollover-per-year-rule. The recharacterization request may not be revoked or modified after it has been processed. Consult a tax advisor or your investment representative for rules and deadlines.
